If you pay Income Tax please read this!!

If you are a UK tax-payer, then thanks to the Government's Gift Aid scheme, you can make your donations and membership payments worth 25% more to us, at no extra cost to yourself!

The scheme works by letting us claim back the tax that you have paid on your donations to us. All we need to enable us to claim the tax back from the Inland Revenue is a single signed Gift Aid declaration form from you. That single form will then cover any number of donations from you, of any size, at any time in the future. We just need to have the form on our file when we receive a gift from you, and we can then automatically reclaim the tax that you have already paid on your donation. We can also reclaim tax paid on donations that you have made to us for up to four years prior to the date you sign the form.

Please note that we can only reclaim tax on donations and membership subscriptions. If you give us money in exchange for goods, raffle tickets, etc., then that is not eligible.

So if you are a tax-payer, please complete and sign the Declaration form overleaf and return it to us at Brent Lodge. The form enables you to specify whether you want us to claim tax on your past and all future donations, only on future donations, or on specific donations.

The only people who should not return the form are those who pay no UK tax, or who always give through a scheme such as CAF, where tax has already been reclaimed.

Signing the form allows us to increase the value the money you give to us. A gift of £10, covered by a Gift Aid declaration, will be worth £12.50 to us. The difference will pay for 5 cans of cat food to feed our patients!
